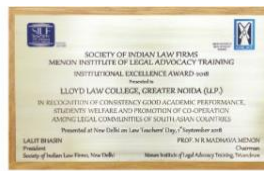

A. "How to organize your law school days?"

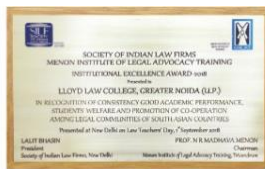

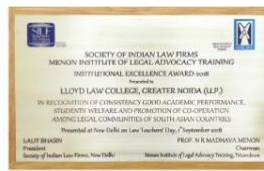
