3. Each and every students will carry their Lloyd Welcome Kit Bag / Personal Bag for taking their book bank from the library on the designated day and time.
4. All the regular classes will continue to be held as per schedule during the Book Bank Disbursal Process.
5. Detailed rules and regulations specific to the Library, Issue and Return of Books, Book Bank Books, Take Away Gift Books etc. are provided in the student hand book (provided with the welcome kit bag) and also provided below.

BOOK-BANK POLICY ::

- Lloyd Library provides entire set of BOOK-BANK Books for each and every student in the beginning of the semester.
- All students who are availing the facility must ensure returning the entire set of books provided to them within two days of completion of their final examination in the concerned semester/Term.
- If the books are lost or damage, then the borrower shall replace the books of the same edition or latest edition or pay current cost of the book after getting permission from the Librarian and pay in account department
- Students are requiring to handle the books/ Journals very carefully; marking with pencil, writing or highlighting, tearing the pages or mutilating the same in any other way will be viewed very seriously. In such case reader shall be held responsible unless these are brought to the notice of the Library-Staff at the time of return.



- Books will be issued on presentation of the Library-card along with ID-Card. Students are instructed to check the books while borrowing and they will be responsible for any damage or mutilation noticed at the time of return.
