The winning team from the India Rounds will earn the honour of representing the country in the International Rounds at the **University of Glasgow, Scotland, from 8th to 12th April 2025**.

**Judging Criteria ::** Open Challenger will be judged based on the following criteria:

- Establishing the working atmosphere and professional approach.
- Eliciting the problem of the client and the tools used in doing so.
- Clients' goals, expectations and needs.
- Analysis and formulation of the problem with precision.
- Suggesting alternatives.
- Allowing the client to make informed choices.
- Effective conclusion of the counselling session.
- Team work.
- Management of ethical and professional relation with the client – dealing with emotional and legal needs of the client.
- Post interview session interaction with the Judges/among themselves.

### Rules of the Open Challenger & Selection Round ::

- Participants shall take up the role of advocates wherein a client would narrate to them a problem situation. The advocate is required to interview the client and provide effective advice and suggest suitable remedy.
- The theme of the challenger round shall be "consumer and contract law."
- Participants shall be allowed to bring and refer their own books, bare acts, notes etc., however use of any electronic devices shall be strictly prohibited.
- The students may participate in a team consisting of maximum two members. However, solo participation is also allowed.
- It shall be the discretion of the Judges and authorities to select individual participants from the team even though entire team may not be selected.
- The judges and the authorities may not select any participants if none of them appear to be appropriate for participation in the national rounds.
- Last date to register for the Open Challenger round is 3<sup>rd</sup> Feb 2025, 12 AM. No request for delay or extension shall be entertained.

**Eligibility to Participate :: All the Senior Batches of B.A.LL.B. / B.Com.LL.B. / LL.B., Not Open to First Year students**

### Obligations ::
