Dr. Atyab Siddiqui is a brilliant first class "Hons of Laws and History" from the University of Delhi. He is a litigating lawyering in the Supreme Court of India and practically all the High Courts and Tribunals of the country since 1986. He has completed 35 years of core litigation practice in the courts. For his immense services to the legal fraternity and society, Dr. Siddiqui has been conferred with the Honorary Doctor of Law by the Royal American University, Newark, Delaware, United States of America on the 10th Nov. 2021. He is teaching Code of Civil Procedure, Rent Control legislations, Administrative law, Constitutional law, Evidence and Practical Training to law students in various law schools of India, U.K. and other countries. Dr. Siddiqui has been regularly delivering lectures on humanism, education and administrative transparency to IPS officers at the National Police Academy Hyderabad, and to higher officials of the Telangana and Madhya Pradesh states. He has addressed judicial officers on various legal themes.

He has delivered lectures in many prominent universities across the globe, especially in Europe and the Middle-east on a discursive range of lego-societal issues. Dr. Siddiqui has written three books. "I Love I Hate" is his commentary on various social political issues facing the country. Another book, "Law of Education" (foreword written by Justice A.K. Sikri) is unmatched for lawyers dealing with educational matters and service jurisprudence. The third one is published by the Oxford University, London on educational legacy of Delhi. Mr. Siddiqui is an acclaimed panelist on TV on legal issues and rights of women, constitution and civil liberties. His legal and societal articles are published in various journals and newspapers.

Dr. Siddiqui has very closely studied the criminal system of jural dispensation of England, as also the modernisation of its educational structures especially from the perspective of racial equality. He is an expert on Right to Education and is advising prominently the Tata Trusts in their social empowerment schemes. Dr. Siddiqui has visited Europe, Africa major parts of Asia for academic pursuits.
