#### Frankfurt Investment Arbitration Moot Court ::

The Frankfurt Investment Arbitration Moot Court is the oldest and most prestigious student competition in the area of investment protection law. Its focus is on the oral presentation of legal arguments before an arbitral tribunal composed of specialists in the field during a one-week finalevent, the National rounds of which take place in March of and the International rounds take place in Germany in June, every year. The Frankfurt Investment Arbitration Moot Court is unique in that it combines the law of investment protection, one of the most modern and fastest developing areas of international law, with the history of international law and of international trade.

#### Rules of the Competition ::

- It shall be the discretion of the Judges and authorities to select individual participants from the team even though entire team may not be selected.
- The judges and the authorities may not select any participants if none of them appear to be appropriate for participation in the international rounds.
- The students may participate in a team consisting of maximum two members.



However, solo participation is also allowed.

- The teams/solo participants must send their nominations through the google form provided.
- The teams/solo participants must submit a skeletal memorial by **Thursday- 6<sup>th</sup>-02-2025**, The same shall be mailed to [lloydlawcollege.frankfurt23@gmail.com](mailto:lloydlawcollege.frankfurt23@gmail.com) and cc to [agrani.khare@lloydlawcollege.edu.in](mailto:agrani.khare@lloydlawcollege.edu.in) by the end of the day (EOD).
- Presentation time is 10-20 minutes for each speaker.

### **Criteria for Adjudication ::**

The participants shall be judged upon the following criteria:

- Knowledge of facts
- Logic and reasoning
- Organization and clarity
- Persuasiveness
- Deference to the court
- Proper and articulate analysis of the issues arising out of facts
- Understanding of the legal principles directly applicable to the issues
- Ability to explain clearly the legal principles in general keeping to the time allotted
- Knowledge and use of legal sources and authorities and general principles of international arbitration
- Ingenuity (ability to argue by analogy from related aspects of law).

### **Eligibility to Participate ::**

This Open Challenger is open for the following batches only. All the students of B.A.LL.B./B.Com.LL.B. (2021-26), (2022-27), (2023-28) and LL.B. (2023-26).

### **Obligations ::**

- The Selected Students shall work from 03 PM -to- 08 PM in Campus on class Days and from 09 AM -to- 08 PM on Non-class Days.
- No exceptions shall be granted to any student from this rule irrespective of any situation or condition. THERE IS NO WORK FROM HOME.
- During the preparation time, generally no leaves will be granted to the team members. In case of emergency, the same will be done with prior intimation and approval.
- The members cannot at any cost, miss any meeting called by the mentors or authorities.
