32nd VIS MOOT, VIENNA, 11 - 17 April 2025 ::

The Willem C. Vis International Commercial Arbitration Moot is a competition for law students to foster the study and practice of international commercial sales law and arbitration. Students from all countries are eligible (students from 88 countries participated in the 31st Vis Moot). The Moot involves a dispute arising out of a contract of



sale between two countries that are party to the United Nations Convention on Contracts for the International Sale of Goods.

22nd VIS EAST MOOT, Hong Kong, 30 MARCH – 6 April 2025 ::

The Vis East Moot Competition is the sister competition to the Willem C. Vis International Commercial Arbitration Moot in Vienna. Given the continuous and rapid expansion of the economy in Asia, international commercial transactions and, inevitably, cross-border disputes in Asia are on the rise. The Vis East Moot provides law students, academics, and professionals with a similar exposure to, and experience in, international arbitration and trade law as the Vis Moot in Vienna, but with an Asian context.

SELECTION STRUCTURE ::

- Interested individual can register themselves by uploading a Statement of Purpose (SOP) explaining their interest and motivation (in not more than 250 words) to participate in the Willem C. VIS Moot International Commercial Arbitration Moot Court Competition 2025.
- Based on the SOPs received individuals will be paired into a team of 02 members.
- Each team with 02 members will prepare written submissions from both sides based on the rules and regulations provided by the deadline.
- Failure to submit the written memorandums by deadline will result in disqualification from the selection rounds.
- No extension will be provided regardless of however grave or exception the circumstances be.
- All teams who have submitted their memorandums will be paired against another team as Claimant or Respondent to participate in the Oral Rounds.
- After completion of both the rounds, individuals will be selected based on the collective scores of both written and oral submissions.

ELIGIBILITY ::

1. This Competition is **OPEN FOR ALL** Bona-fide students of Lloyd Law College and Lloyd School of Law currently pursuing their degrees in the B.Com.LL.B./B.A.LL.B. and LL.B. programs.
2. This Competition is **NOT OPEN FOR ALL** students of B.Com.LL.B. (2024-2029), B.A.LL.B. (2024-2029) and LL.B. (2024-2027).
