Mr. Yash is alumnus of Symbiosis Law School, Noida. He joined the Bar in the year 2018 and started practicing as a lawyer in Delhi NCR and had appeared before various Hon'ble Courts and Tribunals. He is the Founder and Head Litigator at Kotak & Associates, Advocates. He specializes in commercial litigation with specific interest in intellectual property rights and insolvency law. He also oversees Corporate Criminal Proceedings including white collar crimes and money laundering. He has regularly appeared before the Prevention of Money Laundering Tribunals to protect the interests of the Banks and before Special Courts to defend accused persons undergoing accusations of siphoning of funds, smuggling, mis-declarations in custom goods etc. He was also appointed as a Local Commissioner and a Receiver to discharge the directives of the Court under securitization law (SARFAESI). On the academic front, Yash has delivered lectures in various law colleges and is regularly invited to judge moot-court competitions. Recently, Yash conducted a Two Day Online Certified Course in conjunction with Law Administration in relation to drafting and pleadings in Criminal and Civil matters.
