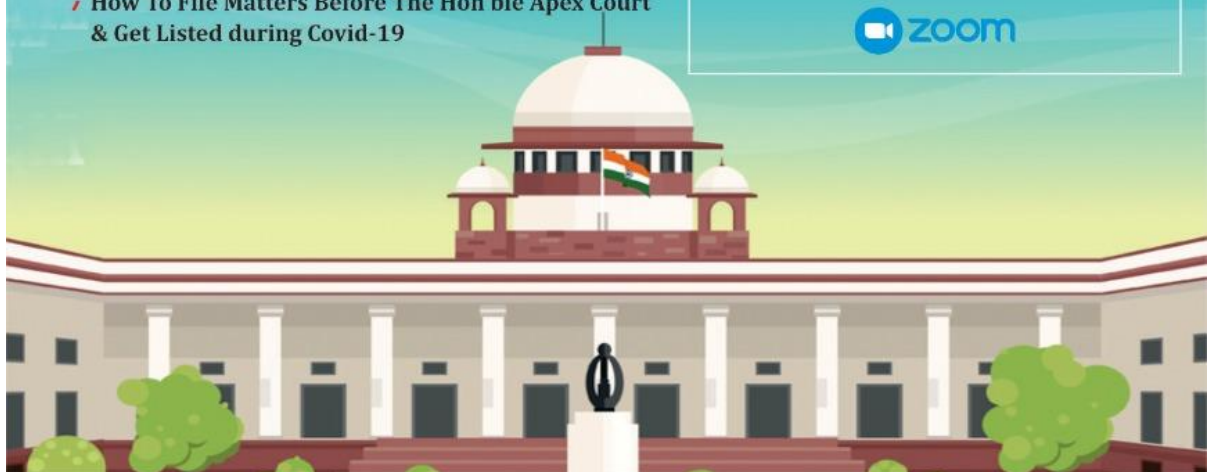

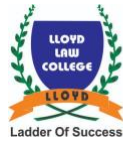

#### Course Preface :: Supreme Court Practice & Procedure

The Hon'ble Supreme Court of India has recently seen an upsurge in the number of young counsels filing and arguing matters before it. However, the thirst for a greater number of Advocates-on-Record passing the examination each year is far from being quenched. Presented with dense and complex questions for interpretation daily, the highest Constitutional Court of the country has formulated a specific set of rules and regulations so as to ease out the procedures of filing, listing and arguments. The Supreme Court Rules of Practice and Procedure, 2013 framed under Article 145 of the Constitution of India are exhaustive guidelines highlighting the practical aspects of an advocate's daily litigation practice. Augmenting dimensions of judicial review, dilution of the doctrine of separation of powers and supremacy of the Rule of Law pave way for the various kinds of jurisdictions with which the Hon'ble Supreme Court is bestowed, be it Original, Advisory, Appellate, Writ, Review, Curative, Inherent, Contempt or *Suo - Moto*. So here I am, introducing you to a completely NEW WORLD OF PRACTICE which by far has been the most interesting part of my young experience in the profession. In particular, this course aims to:

- Explore the practical nuances and procedural aspects of Supreme Court litigation and practice by undertaking an in depth study of the Indian Constitution and Supreme Court Rules of Practice & Procedure, 2013.
- Compare and contrast the different types of jurisdictions of the Hon'ble Supreme Court of India by exploring their nature, origin and application.
- Analyze the mode of listing of matters before the appropriate benches of the Hon'ble Apex Court.

This is a customised course for introducing law students of the final year batches with an interest in Constitutional Laws to an entirely novel world of Supreme Court Practice. The



course also caters to those Indian law students who wish to upgrade their qualification for the purpose of career specialization in civil and criminal (constitutional law) litigation/dispute resolution.

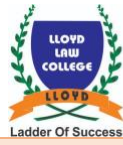
