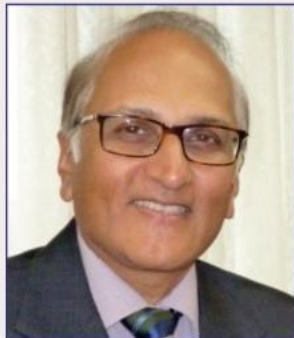

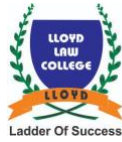

- Lloyd Law College / Lloyd School of Law Uniform.

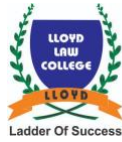
Lloyd Institute of Mediation and Arbitration :: LIMA
