#### **Introduction ::**

In contemporary times, classroom teaching for a student of law degree program remain insufficient as potential recruiters look for law graduates who are not only well versed with the Bare Acts, but who also possess adequate practical knowledge and are familiar with working of the Courts. Apart from this, fluency in communication skills, including good drafting skills is necessary for a law graduate. This all can't be covered in class-room teaching; it has become essential for every law college to take the teaching & learning beyond class-rooms and to bring in the element of understanding & application of law in its curriculum. Considering this, we have adopted this policy document.

#### **Object ::**

The Object of this policy is to have all round development of the students through their compulsorily participation in various skill development and training activities.

#### **Vision ::**

Our vision is that skills development has become a culture at our law school, and the fraternity & the community finds law graduate from our law school one of the best law graduate in all the contemporary times.

#### **Mission ::**

This policy has been adopted to establish a structure which ensures that the students have been trained in a manner which provides them with the best possible opportunity to grab prestigious jobs right after the completion of their law degrees. During the training of five/three years, they find their area of interest so they could join the same once they graduate and keep enjoying the same throughout their career.

#### **The Policy ::**

In order to achieve the vision and mission, the following shall be implemented from the Academic Year 2022-23;

1. Regular classes of the course subjects shall keep taking place as usual from 9:00 am to 3:00 pm.
2. From 03:30 -to- 06:30 pm 04 days a week, there shall be compulsory 'skill development program' and 'training activities',
3. These classes on 'skills development' and 'training activities' shall primarily cover the industry specific knowledge and skills training program as mentioned below.
4. Each semester shall have a set of skills development program modules, the same shall be prepared & executed by the experts in the respective field.
5. The activity classes shall have a separate attendance register and 75% attendance in the same shall be mandatory, apart from mandatory attendance of 75% in regular classes. However, this attendance shall not be considered for the purpose of 'sitting in the university examination'. But, this attendance shall be considered for any other benefit that may be enjoyed by the student, like, 'internship & placement support',



'certificate of respective activity', 'participation in any activity at the college or beyond the college', etc.

6. SDP module-wise diary of each student shall be maintained in which attendance, participation, and performance in respective course shall be recorded on daily basis.
7. These classes shall be run and managed by a set of professional and expert trainers.
8. 100% of the students who have been trained in this manner shall be provided with the best industry standard internships and placement opportunities from the college.
9. STUDENTS' OF LLOYD ENROLLED IN THE YOUR-LORDSHIP JUDICIAL COACHING PROGRAM WILL BE PARTICIPATING ONLY IN THE JUDICIAL COACHING AND ARE EXEPTED FROM THIS SDP.

**10. Participation under SDP-based training activities shall be mandatory for all the students of BA.LL.B./B.Com-LL.B. (Batches 2018-23, 2019-24, 2020-25, 2021-26 & 2022-27,) as per the schedule provided to each respective batches.**

We are sure that you can foresee the benefits that the SDP based activities is going to bestow upon each successful participating student. It will enhance employability of the student that will be at par with any student from either of the best law schools in the country. The only thing required to be at par with any other student from either of the best law schools is: participating with sincerity, zeal & enthusiasm in the SDP based experiential learning program. To ensure the above, all the SDP based activities will be guided by a team experts from the relevant domain.
