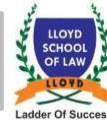

This year we have taken a step forward and had the privilege of conducting the South Asia Regional Rounds of Foreign Direct Investment Moot, 2024 at our campus.

To take the legacy forward it was important to take inspirations from previous participations and organize a diverse and more intense selection rounds for Willem C. VIS International Commercial Arbitration Moot 2025. This year the selection of individuals as part of the team will be based on the collective scores of both written and oral submissions.

Firstly, we are thrilled and grateful to share that we received an overwhelming response this year, **with over 100 applications** for the internal selection rounds of Willem C. This decision was made with the goal of maintaining the quality and efficiency of the rounds.

We deeply appreciate the efforts of all participants who took the time to apply. For those who were not shortlisted this time, we strongly encourage you to explore more national and international moot court competitions and return with greater experience for future editions of this moot. Your commitment and dedication are inspiring, and we look forward to seeing your continued growth and success.

- No extension will be provided regardless of however grave or exception the circumstances be.
- All teams who have submitted their memorandums will be paired against another team as Claimant or Respondent to participate in the Oral Rounds.
- After completion of both the rounds, individuals will be selected based on the collective scores of both written and oral submissions.
